## CONDITIONS OF CONTRACT FOR BOARDING

All animals boarded or cared for by Wanneroo Boarding and Grooming are accepted on the following terms and conditions. **2** Animals to be 4 months old or over and to be fully vaccinated. No animals will be accepted without a vaccination certificate from a veterinary surgeon. **3 If the animal requires veterinary attention the owners are liable for all costs and out of pocket expenses, in the event of serious illness or accident and the owner cannot be contacted the veterinary surgeons decision relating to the treatment of the animal will be final. 4** Animals not collected within 14 days of the specified date will be disposed of at the discretion of Wanneroo Boarding Kennels and Grooming. All monies owing including fees and costs relating to the disposal, are payable by the owner immediately upon receipt of invoice for Wanneroo Boarding Kennels and Grooming. **5** Should the customer default in the payment of any monies due under this agreement then all monies due to Wanneroo Boarding Kennels and Grooming shall immediately become due and payable and shall be paid by the customer within (7) days of the date of demand and Wanneroo Boarding Kennels and Grooming shall be entitled to charge interest, the rate of 15% per annum on all overdue accounts from the due date until the date of actual payment. **6** Any expenses, cost or disbursement, incurred by Wanneroo Boarding Kennels and Grooming in recovering or attempting to recover any outstanding monies including Debt Collection Agency Fees and Solicitors Costs shall be paid by the customer, providing that those fees do not exceed the scale of charges by the Debt Collection Agency / Solicitor and in any event the commission is not exceed 18 per centum of the debt value, plus out of pocket expenses. **7** If animals are boarded for more than (2) weeks, 50% of the boarding Fee must be paid in advance. **8** Wanneroo Boarding Kennels and grooming reserve the right to refuse any animal and no reason shall be given. **9** Minimum charge of two (2) calendar days. Boarding rates are charged on a calendar day basis irrespective of the time of admission or departure and does not include bathing grooming or other additional services. **10** A deposit as set by Wanneroo Boarding Kennels and Grooming is payable for each animal booked. Refunds are only available if notice of cancellation is given at least four (4) weeks prior to the booked date. An administration fee of 15% will be deducted from the returned deposit. **11** The fully booked period will be charge during all school holidays. **12** The owner agrees to pay the rate for boarding in effect on the day the animal is checked into Wanneroo Boarding Kennels and Grooming (as advised in the price list displayed in the kennel office). **13** The owner agrees to pay all costs and charges for service requests and all veterinary costs for the animal during the time the said animal is in the care of Wanneroo Boarding Kennels and Grooming. **14 The owner agrees to be solely responsible for any and all things done by the animal how ever resulting while the animal is in the care of Wanneroo Boarding Kennels and Grooming including acts of all things done while the animal is under the direct supervision of Wanneroo Boarding Kennels and Grooming or a member of Wanneroo Boarding Kennels and Grooming staff or a subcontractor or any other person engaged by Wanneroo Boarding Kennels and Grooming staff or a subcontractor or any other person engaged by Wanneroo Boarding Kennels and Grooming. The owner will pay to Wanneroo Boarding Kennels and Grooming all expenses of and for any liability Incurred by Wanneroo Boarding Kennels and grooming by the reason of the animals nature, temperament behaviour or actions while the animal is in the care of Wanneroo Boarding Kennels including any costs , loss and expenses arising out of financial liability resulting from the behaviour of the animal. 15** The owner specifically represents that he/she is the sole owner of the animal free and clear of liens and encumbrances. **16** All charges incurred by the owner must be paid before the animal leaves Wanneroo Boarding kennels and grooming or its agency. **17** The owner releases Wanneroo Boarding Kennels and Grooming and its employees or agents from all liability of any kind what so ever that may occur to any animal in the care of or staying at Wanneroo Boarding Kennels and Grooming facility including injury, death, loss or damage while under the supervision of Wanneroo Boarding Kennels and Grooming its staff, agents or subcontractors. **18** By signing these conditions contract and leaving his/her animal with Wanneroo Boarding Kennels and grooming the owner warrants the accuracy of all information given about the animal. The owner acknowledges that the signing of this contract shall create a lien over the animal in the favour of Wanneroo Boarding Kennels and Grooming which lien shall continue to exist whilst ever monies are owing pursuant to the contract.

I acknowledge I have read the above conditions of contract for boarding my animal with Wanneroo Boarding Kennels and Grooming and that the terms and conditions set out above apply and will regulate my contract for the care of my animal by Wanneroo Boarding Kennels and Grooming and that all the terms of my contract with Wanneroo Boarding Kennels and grooming are set out in this contract and I cannot rely on any earlier contract or on any statements made in negotiations leading to my entering into this contract.
